Restructuring

On 01-Dec-2014, Tecity Pte. Ltd., its related corporations and associated companies (collectively, the "Tecity Group") undertook a restructuring. After the restructuring, the shares of the entities in the Tecity Group are held, both directly and indirectly, by one holding company, being Tan Chin Tuan Pte. Ltd. ("TCTPL").

As part of the restructuring, TCTPL acquired shares representing more than 50 per cent. of the issued share capital of Grange Investment Holdings Private Limited ("Grange"), a substantial shareholder of STC which is deemed interested in the STC shares held by The Cairns Pte. Ltd..

Relationship between Substantial Shareholders

On 3 December 2013, a substantial shareholders' notification made by The Cairns Pte. Ltd., Raffles Investments Limited, Siong Lim Private Limited, Tecity Pte. Ltd, Aequitas Pte. Ltd., Kambau Pte. Ltd., Grange and Dr Tan Kheng Lian was released via SGXNET ("3 December Notification").

Following the restructuring, TCTPL holds more than 50 per cent. of the voting rights of Grange, a substantial shareholder of STC which is deemed interested in the STC shares held by The Cairns Pte Ltd. ("Cairns"). By virtue of this, TCTPL has a deemed interest in the STC shares held by Cairns.

Notwithstanding the disclosure made in this notification, there are no changes to the deemed interests in the STC shares held by each of the substantial shareholders as disclosed in the 3 December Notification.

In this form, unless otherwise stated, the percentage figures have been calculated on the basis of 408,095,772 STC shares, based on information obtained from Announcement Reference SG141114OTHRKQV0 released via SGXNET on 14-Nov-2014 20:00:22.
