#### 1. INTRODUCTION

The Straits Trading Company Limited (the "Company") wishes to refer shareholders of the Company ("Shareholders") to:

- (a) the announcement dated 14 August 2022, where the Company announced that it is proposing to undertake a distribution *in specie* (the "**Proposed Distribution**") of new ordinary shares of the Company ("**Straits Shares**"), or at Shareholders' election, up to 62,758,837 ordinary shares (the "**ESR Distribution Shares**") in the issued share capital of ESR Group Limited ("**ESR**") to Shareholders.
- (b) the announcement dated 15 September 2022, where the Company announced (i) the receipt of approval-in-principle for the listing and quotation of up to 23,698,245 New Straits Shares for the Proposed Distribution; and (ii) an update on the Shareholders' approval for the Proposed Distribution; and
