# Please specify details	<p>On 24 April 2006, The Straits Trading Company Limited (STC) lodged a copy of the Order of Court approving and confirming the selective capital reduction (SCR) with the Registrar of Companies. After the SCR, the total number of issued ordinary shares in STC ( the STC shares) has been reduced from 356,400,000 to 325,897,000.</p> <p>As a consequence of the SCR, Siong Lim Private Limited's aggregate direct and deemed interest in the STC shares has changed from 8.735% to 9.553%.</p> <p>In addition to its direct holding of STC Shares, Siong Lim Private Limited is, pursuant to the Companies Act of Singapore, deemed to be interested in the STC Shares held by Raffles Investments Ltd, Raffles Investments (Singapore) Pte Ltd and Mellford Pte Ltd.</p>
