The Straits Trading Company Limited (the "Company") announced on 15 October 2024 that it had, on the same date, launched a S\$55 million multicurrency multi-tranche unsecured commercial paper facility programme (the "SDAX CP Facility Programme"). The commercial papers to be issued under the SDAX CP Facility Programme will be represented by digital tokens ("Tokens").

In connection with the above, the 3-month Series 002 SDAX Issuance and the Tokens representing 3-month Series 002 SDAX Issuance, were issued on 23 January 2025, and have matured on 23 April 2025.

Accordingly, the 50 Tokens under the 3-month Series 002 SDAX Issuance (with an aggregate principal amount of S\$500,000) that were issued to Ms. Chew Gek Khim, have been fully redeemed on 23 April 2025.
